## **CITY OF DARDENNE PRAIRIE PROPOSITION P**

Shall the municipality of the City of Dardenne Prairie, Missouri, impose a sales tax of one-half of one percent (0.5%) for the purpose of providing funding for local parks and storm water control for the municipality?

### **PROPOSITION A-1 (INSIDE AND OUTSIDE CITY LIMITS)**

Shall the city limits of the City of Dardenne Prairie, in the County of St. Charles, Missouri, be extended so as to embrace and include all that part of the County of St. Charles consisting of approximately 2.98 Acres, with a street address of 7283 Hwy N, generally situated on the north side of Hwy N between Rondale Court and Monet, and as more specifically described in Ordinance No. 1868 of the City of Dardenne Prairie, Missouri?

### **PROPOSITION A-2 (INSIDE AND OUTSIDE CITY LIMITS)**

Shall the city limits of the City of Dardenne Prairie, in the County of St. Charles, Missouri, be extended so as to embrace and include all that part of the County of St. Charles consisting of approximately 5.69 acres, with a street address of 7275 Hwy N, generally situated at the northeast corner of Hwy N and Monet Drive, and as more specifically described in Ordinance No. 1869 of the City of Dardenne Prairie, Missouri?

**PROPOSITION A-3**  
**(INSIDE AND OUTSIDE CITY LIMITS)**

Shall the city limits of the City of Dardenne Prairie, in the County of St. Charles, Missouri, be extended so as to embrace and include all that part of the County of St. Charles consisting of approximately 4.18 acres, with a street address of 1332 Feise Road, generally situated at the southeast corner of Feise Road and Langrove Drive, and as more specifically described in Ordinance No. 1870 of the City of Dardenne Prairie, Missouri?

**(INSIDE AND OUTSIDE CITY LIMITS)**

Shall the city limits of the City of Dardenne Prairie, in the County of St. Charles, Missouri, be extended so as to embrace and include all that part of the County of St. Charles consisting of approximately 14.22 acres, with a street address of 7717 Hwy N, generally situated near the southwest corner of Hanley Road and South Outer 364, and as more specifically described in Ordinance No. 1874 of the City of Dardenne Prairie, Missouri?

**(INSIDE AND OUTSIDE CITY LIMITS)**

Shall the city limits of the City of Dardenne Prairie, in the County of St. Charles, Missouri, be extended so as to embrace and include all that part of the County of St. Charles consisting of approximately 6 acres, with a street address of 7800 Hwy N, generally situated on the south side of Hwy N between Post Road and Keystone Crossing Drive, and as more specifically described in Ordinance No. 1875 of the City of Dardenne Prairie, Missouri?
