PROPOSITION E

Shall the Board of Education of the Wentzville R-IV School District, St. Charles County, Missouri, borrow money in the amount of One Hundred Twenty-five Million Dollars (\$125,000,000) for the purpose of acquiring, constructing, renovating, repairing, expanding, improving, furnishing and equipping school sites, buildings and related facilities for school purposes in the District, including, but not limited to (1) constructing, furnishing and equipping a new high school and an elementary school and (2) improving certain of the District's existing school buildings and related facilities for school purposes, and issue general obligation bonds for the payment thereof, resulting in an estimated increase in the debt service property tax levy of zero cents (\$0.00) per one hundred dollars of assessed valuation? If this proposition is approved, the adjusted debt service levy of the Wentzville R-IV School District is estimated to remain unchanged from the current debt service levy of 93.04 cents (\$0.9304) per one hundred dollars assessed valuation of real and personal property.

The authorization of said bonds will authorize the levy and collection of an annual tax in addition to the other taxes provided for by law on all taxable tangible property in the District sufficient to pay the interest and principal of said bonds as they fall due.
